





### Delivering on Our Goals

To fulfil our aims and objectives and achieve our goals, we need to work systematically and strategically throughout the organisation. These are our most important tools:

#### ≥ New and Updated Knowledge

The cultural sector, the general public and public authorities need new and updated knowledge about the arts field. Arts and Culture Norway supplies reports and analyses which benefit both professionals and public, and which provide a factual basis for cultural policy decisions.

ACN has a unique overview of the work being done at Norwegian cultural institutions and entities. We are familiar with the major national organisations as well as the smaller but equally important local ones. In addition, we have an extensive global network which gives us an excellent overview of international trends..

#### ☑ More Diversity, Fewer Borders

ACN is the national coordinator for diversity in the cultural sector. We are working actively to encourage more people to get involved as audiences, creators or organisers. Our diversity-promoting activities focus particularly on visible minorities, people with disabilities, the Sámi population and national minorities.

ACN is also responsible for the Creative Europe programme, EEA funds and contact with UNESCO and other international bodies. Culture knows no borders, and everyone is entitled to express themselves through the medium of art and culture.

### ע Innovation and Sustainability

The cultural sector is a driver of social changes at the same time as being affected by them. ACN plays an active role in encouraging innovation and development as crucial factors in realising our vision of a society rich in art and culture.


ACN is working to highlight the impact of art and culture on other areas in society, and is a driving force for the establishment of a more sustainable cultural sector.

#### ☑ Investment, Funding and Administration

One of ACN's most important tasks is to act as the overall administrator of Arts Council Norway, the Government Grants for Artists scheme and the Audio and Visual Fund, which provide investment funding for artists, creators and cultural projects. Grants are awarded following full, professional assessments, and are not affected or influenced by current government policy or ideology.

ACN is also responsible for the administration and development of museums, and assists the Ministry of Culture and Equality in administering funding to performing arts institutions and other cultural organisations and bodies. We provide grants that help to develop the institutional field and assess applications related to national arts buildings.

We safeguard Norway's cultural heritage, while administering schemes to strengthen and document the indigenous culture of the nation's minorities. We also grant funding for amateur dramatic groups and traditional historical dramas.
